

IN THE NAME AND BY THE AUTHORITY OF THE STATE OF IOWA

EXECUTIVE ORDER NUMBER ELEVEN

- WHEREAS, Article IV, section 9 of the Constitution of the State of Iowa provides that the Governor shall ensure the laws are faithfully executed; and
- WHEREAS, executive orders should be reviewed periodically to determine which executive orders should be amended, continue as necessary, or should be rescinded; and
- WHEREAS, some executive orders should be rescinded because they have outlived their original purpose or usefulness because the agencies, councils, and/or task forces have since been disbanded, no longer exist, completed their work, are no longer active, and/or their responsibilities have merged or been subsumed by other agencies, councils and/or task forces; and
- WHEREAS, some executive orders should be rescinded because the duties, entities, programs, and/or responsibilities created by the executive orders have been substantially or wholly codified by federal and/or state law; and
- WHEREAS, some executive orders should be rescinded because the duties, entities, programs, and/or responsibilities created by the executive orders are no longer desired or are outdated; and
- WHEREAS, to ensure an efficient and effective state government, the final disposition of executive orders that are amended, expired, rescinded, or superseded should be clearly ascertainable; and
- WHEREAS, all executive orders remain in effect unless they expire on their own terms, are rescinded, or superseded; and

NOW, THEREFORE, I, KIMBERLY K. REYNOLDS, Governor of the State of Iowa, by virtue of the power and authority vested in me by the Constitution and statutes of the State of Iowa, do hereby **ORDER** and **DIRECT** that, unless otherwise already amended or rescinded in accordance herewith, the following Executive Orders be amended or rescinded:

- 1. Executive Order Number 1, dated May 14, 1964, issued by Governor Harold E. Hughes, shall be rescinded because it has been superseded by state and federal law.
- 2. Executive Order Number 2, dated October 7, 1964¹, issued by Governor Harold E. Hughes, shall be rescinded because the event occurred.
- 3. Executive Order Number 3, dated December 17, 1965, issued by Governor Harold E. Hughes, shall be rescinded because the legislature has enacted the Uniform Criminal Extradition Act.
- 4. Executive Order Number 4, dated June 2, 1966, issued by Governor Harold E. Hughes, shall be rescinded because the event occurred and the legislature has enacted a compact for education in Iowa Code section 272B.1.

- 5. Executive Order Number 5, dated on or about June 30, 1966², issued by Governor Harold E. Hughes, shall be rescinded because the event occurred.
- 6. Executive Order Number 6, dated November 7, 1966, issued by Governor Harold E. Hughes, shall be rescinded because the Office of the State Comptroller no longer exists.
- 7. Executive Order Number 8, dated August 24, 1967, issued by Governor Harold E. Hughes, shall be rescinded because the Office of Planning and Programming within the Office of the State Comptroller no longer exists.
- 8. Executive Order Number 10, dated February 19, 1968, issued by Governor Harold E. Hughes, shall be rescinded because the Department of Social Services no longer exists.
- 9. Executive Order Number 11, dated February 19, 1968³, issued by Governor Harold E. Hughes, shall be rescinded because the information was submitted and the Office for Planning and Programming no longer exists.
- 10. Executive Order Number 1, dated August 20, 1969, issued by Governor Robert D. Ray, shall be rescinded because the Governor's Economy Committee submitted its final report and recommendation to the legislature in 1969.
- 11. Executive Order Number 2, dated November 12, 1970, issued by Governor Robert D. Ray, shall be rescinded because it is no longer needed as federal law now heavily regulates vehicle air pollutants.
- 12. Executive Order Number 3, dated February 5, 1971, issued by Governor Robert D. Ray, shall be rescinded because the Governor's Program and Council for Rural Community Development no longer exists.
- 13. Executive Order Number 4, dated February 26, 1971, issued by Governor Robert D. Ray, shall be rescinded because the Drug Abuse Authority no longer exists.
- 14. Executive Order Number 5, dated March 27, 1971, issued by Governor Robert D. Ray, shall be rescinded because it has been superseded by state and federal law.
- 15. Executive Order Number 6, dated January 17, 1972, issued by Governor Robert D. Ray, shall be rescinded because it is outdated, and the duties of the State Print Shop are now organized under the Department of Administrative Services in Chapter 8A.341 et. seq.
- 16. Executive Order Number 7, dated March 28, 1972, issued by Governor Robert D. Ray, shall be rescinded because the Drug Abuse Authority no longer exists.
- 17. Executive Order Number 15, dated April 2, 1973, issued by Governor Robert D. Ray, shall be rescinded because the requirements are now mandated in state and federal law.
- 18. Executive Order Number 17, dated November 12, 1973, issued by Governor Robert D. Ray, shall be rescinded because it is no longer necessary given advancements in technology related to energy-conservation appliances and equipment, including HVAC systems, subsequent conservation standards established by federal law, and the prohibition on state vehicles from exceeding fifty miles per hour was superseded by Iowa Code chapter 321.

- 19. Executive Order Number 19, dated February 28, 1974, issued by Governor Robert D. Ray, shall be rescinded as it is superseded by law and speed limits are set by Iowa Code chapter 321.
- 20. Executive Order Number 24, dated June 30, 1977, issued by Governor Robert D. Ray, shall be rescinded because following the merger the Department of Substance Abuse no longer exists and the functions are now codified within the Department of Heath and Human Services.
- 21. Executive Order Number 27, dated September 14, 1977, issued by Governor Robert D. Ray, shall be rescinded because the Task Force on Government Ethics no longer exists, and the legislature has enacted Iowa Code chapter 68B and created in section 68B.32 an independent Ethics and Campaign Disclosure Board to assist government employees and agencies.
- 22. Executive Order Number 28, dated November 5, 1977, issued by Governor Robert D. Ray, shall be rescinded because the Iowa Paperwork Task Force no longer exists and submitted its final report in 1978.
- 23. Executive Order Number 30, dated December 20, 1977, issued by Governor Robert D. Ray, shall be rescinded because the implementation of funding procedures occurred.
- 24. Executive Order Number 42, dated March 24, 1982, issued by Governor Robert D. Ray, shall be rescinded because the Forms Control Committee no longer exists.
- 25. Executive Order Number 45, dated August 6, 1982, issued by Governor Robert D. Ray, shall be rescinded because it is outdated and Iowa Code section 352.13 outlining the responsibilities for the Interagency Resource Council was later repealed.
- 26. Executive Order Number 46, dated December 21, 1982, issued by Governor Robert D. Ray, shall be rescinded because it is outdated and superseded by state and federal law.
- 27. Executive Order Number 47, dated December 29, 1982, issued by Governor Robert D. Ray, shall be rescinded because the State Job Training Coordinating Council filed its last report in 1990 and is no longer active.
- 28. Executive Order Number 51, dated January 13, 1983, issued by Governor Robert D. Ray, shall be rescinded because the Iowa High Technology Commission submitted its final report in 1983, has completed its work and is no longer active.
- 29. Executive Order Number 2, dated July 1, 1983, issued by Governor Terry
 E. Branstad, shall be rescinded because the Committee on Widowed
 Persons has completed its work and is no longer active.
- 30. Executive Order Number 3, dated July 1, 1983, issued by Governor Terry E. Branstad, shall be rescinded because the Iowa High Technology Commission is no longer active.
- 31. Executive Order Number 7, dated December 16, 1983, issued by Governor Terry E. Branstad, shall be rescinded because it is no longer needed as the Vietnam Veterans Memorial was completed on May 28, 1984.
- 32. Executive Order Number 11, dated March 30, 1984, issued by Governor Terry E. Branstad, shall be rescinded because the requirements are mandated by state and federal law.

- 33. Executive Order Number 15, dated January 29, 1985, issued by Governor Terry E. Branstad, shall be rescinded because the Iowa Economic Development Coordinating Committee is no longer active.
- Executive Order Number 17, dated May 16, 1985, issued by Governor Terry E. Branstad, shall be rescinded because it is outdated, and the Iowa Partnership for Economic Progress is inactive and has not met since 2018.
- 35. Executive Order Number 25, dated November 17, 1986, issued by Governor Terry E. Branstad, shall be rescinded because it is no longer needed as an alternate allocation method was enacted by the legislature in Iowa Code chapters 7C and 16 and the relevant administrative rules.
- Executive Order Number 27, dated March 3, 1987, issued by Governor Terry E. Branstad, shall be rescinded because the Interagency Council has completed its work and is no longer active.
- 37. Executive Order Number 32, dated July 7, 1987, issued by Governor Terry E. Branstad, shall be rescinded because the Governor's Alliance on Substance Abuse has been formally codified within the Iowa Department of Public Safety as the Office of Drug Control Policy.
- 38. Executive Order Number 36, dated February 13, 1989, issued by Governor Terry E. Branstad, shall be rescinded because the specific types of biodegradable products outlined in the order are outdated based on technological advancements and market changes to biodegradable disposable products.
- Executive Order Number 40, dated November 1, 1991, issued by Governor Terry E. Branstad, shall be rescinded because the Iowa Drug and Violent Crime Policy Board completed its work and has been disbanded.
- 40. Executive Order Number 48, dated February 14, 1994, issued by Governor Terry E. Branstad, shall be rescinded because the Iowa Commission for National and Community Service is no longer needed as the General Assembly created the Iowa Commission on Volunteer Service (2011 Iowa Acts, chapter 118, HF 590).
- 41. Executive Order Number 58, dated July 1, 1996, issued by Governor Terry E. Branstad, shall be rescinded because it is outdated and unnecessary as a result of amendments codified in Iowa Code chapter 84A.
- 42. Executive Order Number 1, dated January 25, 1999, issued by Governor Thomas J. Vilsack, shall be rescinded due to the creation of the State Workforce Development Board in Iowa Code chapter 84A.
- 43. Executive Order Number 4, dated February 22, 1999, issued by Governor Thomas J. Vilsack, shall be rescinded as it is no longer needed because the 21st Century Workforce Council published its report in 2000.
- 44. Executive Order Number 8, dated September 14, 1999, issued by Governor Thomas J. Vilsack, shall be rescinded because it is no longer necessary as the mandate was completed and the legislature enacted Iowa Code section 17A.7(2).
- 45. Executive Order Number 16, dated March 31, 2000, issued by Governor Thomas J. Vilsack, shall be rescinded because it is no longer needed as the Iowa Food Policy Council dissolved after its final report was submitted in 2004
- 46. Executive Order Number 22, dated October 3, 2001, issued by Governor Thomas J. Vilsack, shall be rescinded because the National Guard mission

- was completed.
- 47. Executive Order Number 23, dated October 12, 2001, issued by Governor Thomas J. Vilsack, shall be rescinded because the National Guard mission was completed.
- 48. Executive Order Number 39, dated January 11, 2005, issued by Governor Thomas J. Vilsack, shall be rescinded as it is no longer needed and has been superseded by statute with the program being codified in sections 15.439 and 15.440 of the Iowa Code (formerly sections 303.3C and 303.3D).
- 49. Executive Order Number 47, dated February 7, 2006, issued by Governor Thomas J. Vilsack, shall be rescinded because the Keep Iowa Clean and Beautiful Task Force submitted its report on June 30, 2006, has been disbanded, and is no longer needed.
- 50. Executive Order Number 49, dated August 4, 2006, issued by Governor Thomas J. Vilsack, shall be rescinded because the Targeted Small Business Task Force submitted its final report in December of 2006 and is no longer needed.
- 51. Executive Order Number 51, dated December 8, 2006, issued by Governor Thomas J. Vilsack, shall be rescinded as it is no longer needed, and the Targeted Small Business Advisory Council has not met since 2013.
- 52. Executive Order Number 8, dated July 16, 2008, issued by Governor Chester J. Culver, shall be rescinded because the Independent Contractor Reform Task Force submitted its final report on December 17, 2008, and is no longer needed.
- 53. Executive Order Number 13, dated May 26, 2009, issued by Governor Chester J. Culver, shall be rescinded to allow for the Department of Administrative Services to more efficiently process state travel claims and take advantage of technological innovations through upgraded state computer systems in an effort to reduce process times, provide employee reimbursement more expediently, and lower costs.
- 54. Executive Order Number 16, dated August 20, 2009, issued by Governor Chester J. Culver, shall be rescinded because the Green Jobs Task Force completed its work and submitted their final report on October 1, 2009, and is no longer needed.
- 55. Executive Order Number 25, dated August 6, 2010, issued by Governor Chester J. Culver, shall be rescinded because the Lake Delhi Task Force has completed its work with the dam being rebuilt and their final report being submitted on December 1, 2010.
- 56. Executive Order Number 71, dated March 7, 2011, issued by Governor Terry E. Branstad, shall be rescinded because it is no longer needed and has been codified in Iowa Code section 17A.4B.
- 57. Executive Order Number 72, dated April 4, 2011, issued by Governor Terry E. Branstad, shall be rescinded because the administrative rule was rescinded pursuant to Iowa Code section 17A.4(7) upon issuance of the order.
- 58. Executive Order Number 75, dated October 24, 2011, issued by Governor Terry E. Branstad, shall be rescinded because the Iowa Partnership for Economic Progress has not met since 2018, and has fulfilled its intended purpose.
- 59. Executive Order Number 77, dated May 11, 2012, issued by Governor Terry

- E. Branstad, shall be rescinded because the administrative rule was rescinded pursuant to Iowa Code section 17A.4(7) upon issuance of the order.
- 60. Executive Order Number 88, dated August 29, 2016, issued by Governor Terry E. Branstad, shall be rescinded because the Future Ready Iowa Initiate and the Future Ready Iowa Alliance have completed their work.
- 61. Executive Order Number 1, dated January 29, 2018, issued by Governor Kim K. Reynolds, shall be *amended* to reflect that the definition of "workbased learning" means opportunities and experiences that include but are not limited to sustained project-based learning in partnership with an employer, simulated work experiences aligned with industry-recognized credentials, high-quality pre-apprenticeships aligned to an apprenticeship, student learner programs, internships, and apprenticeships. (Iowa Code section 256.125, as amended by 2024 Iowa Acts, Senate File 2411, section 17). The Iowa Clearinghouse for Work-Based Learning will continue to include career awareness and exploration opportunities, including guest speakers, career fairs, job shadow days, and other project-based learning opportunities that are not in partnership with an employer.

Executive Order Number 1 is further *amended* to provide that the Iowa Clearinghouse for Work-Based Learning shall operate as a sole venture of the Iowa Department of Education in partnership with area education agencies, local school districts, community colleges, business and industry partners, and other community organizations.

- All other provisions of Executive Order Number 1 shall remain in effect.

 62. Executive Order Number 6, dated June 18, 2019⁴, issued by Governor Kim K. Reynolds, shall be rescinded because the Governor's Economic Recovery Advisory Board has been inactive since it submitted its final report on February 2, 2021.
- 63. Executive Order Number 9, dated June 22, 2021, issued by Governor Kim K. Reynolds, shall be rescinded as the Carbon Sequestration Task Force has been inactive since submitting its final report in August of 2021.

This executive order shall not be interpreted to reinstate any executive order previously rescinded by any of the above executive orders. The Legislative Services Agency ("LSA") for the Iowa Legislature is requested to update their LSA publications to reflect the amendments and/or rescissions contained herein.
