## EXECUTIVE ORDER NUMBER THIRTEEN

- WHEREAS, on October 7, 2023, the terrorist organization Hamas committed evil and inhumane attacks against the people of Israel, taking hostages and killing innocent civilians;
- WHEREAS, incidents of antisemitism have increased since the October 7th attacks, including particularly troubling incidents at colleges and universities across the United States;
- WHEREAS, while I encouraged the presidents of Iowa's regent universities to remain vigilant in taking steps to combat antisemitism and many of Iowa's colleges and universities quickly condemned antisemitic speech and actions, some radical organizations and individuals around the country continue to engage in antisemitic actions on college and university campuses;
- WHEREAS, on March 10, 2025, the United States Department of Education's (USDOE) Office of Civil rights (OCR) announced efforts to ensure colleges and universities across the nation— including Iowa—fulfill obligations owed under Title VI of the Civil Rights Act to protect Jewish students;
- WHEREAS, on April 22, 2025, the ADL (Anti-Defamation League) released its annual Audit of Antisemitic Incidents, which recorded 9,354 incidents of antisemitic assault, harassment, and vandalism across the United States in 2024 the highest number ever recorded by ADL representing a 5 percent increase from 2023, a 344 percent increase over the past five years, and a 926 percent increase over the past decade; the Audit further revealed that Iowa has experienced a 40 percent increase in incidents from 2023 and a 92 percent increase in antisemitic incidents since 2020;
- WHEREAS, Iowa Code Chapter 261H promotes free speech at regent universities and protects speech by the campus community but acts of violence, physical or verbal threats, harassment, or other acts of antisemitic intimidation cannot be confused with freedom of speech and expression; and
- WHEREAS, the State of Iowa reiterates its longstanding support for Israel and Iowa's Jewish community, and continues to condemn any form of threat, harassment, intimidation, hate speech, or other action that endangers the Jewish community or violates state or federal law; and

**NOW, THEREFORE, I, KIMBERLY K. REYNOLDS,** Governor of the State of Iowa, by virtue of the power and authority vested in me by the Constitution and statutes of the State of Iowa do hereby ORDER and DIRECT the following:

I. The Iowa Board of Regents ("Board") shall assist and fully cooperate with the USDOE, as found necessary and appropriate, in the USDOE OCR's

efforts to ensure the regent universities fulfill obligations owed under Title VI of the Civil Rights Act to protect Jewish students.
